**Educational Session:** Update on Community Needs in AA County

How is today's economic environment impacting the lives of at risk women and families in our community? At an elementary school in Annapolis, counselors recently identified 23 students who were clearly hungry because they were stealing food daily. As the economy has worsened, the need for food security, emergency shelter, foreclosure prevention assistance, health care services, financial assistance for rent, medicine and transportation has soared.

We'll meet with experts who can help us understand the scale and scope of need in our community today.

## **General Meeting - Health Care Services: Issues and Gaps**

### **Business Meeting: Approve the Budget**

Location: Anne Arundel Medical Center, Health Sciences Pavilion, Health Sciences Institute, 7th floor, Conference Rooms A & B, 2000 Medical Parkway, Annapolis, MD 21401

Plan to attend a panel discussion featuring representatives of the Stanton Center Health Clinic, the County Health Department and an AAMC physician specializing in the needs of at-risk women and families. We will hear about possible barriers, which could affect the quality of health care for our AA County residents. These barriers could include: affordability, accessibility (transportation, language, wheelchair access, for example) and various organizational issues.

In February, teams of AAWGT Volunteers will work in partnership with Habitat for Humanity and Women Build toward the goal of providing affordable housing for women and families in Annapolis. The Women Build home, formerly part of the Obery Court Public Housing on Clay Street, is a green/LEED certified structure designed by Annapolis architect, Catherine Purple Cherry. Habitat crew leaders and professional staff will train and work with AAWGT volunteers from 8am to 4pm on a Saturday and/or Wednesday in February. Alternatively, AAWGT members can volunteer to be part of the Catering Crew that will buy, prepare and deliver lunch to the work site.

**Summary of Recommended Changes to AAWGT  
Bylaws (for adoption at the AAWGT Jan. 13,  
2009 General Meeting)**

1. The President and VP/President-Elect job descriptions are revised to reflect the "job sharing" nature of the positions.
2. The President may make special appointments (such as an Events Coordinator), who may become voting members of the Steering Committee, if approved by SC.
3. To be eligible for service, Officers no longer have to have been

members for one year, but must be members in good standing. Committee Chairs and Assistant Chairs must also be members in good standing.

4. The "Nominating Committee" becomes the "Leadership Development and Nominating Committee" and will focus on nurturing leadership involvement of existing and new members, while the Membership & Outreach Committee will work on recruiting new members, planning events and retaining existing members.

5. Minutes of meetings will be sent prior to next meeting; more flexible timing.

6. Leadership Development & Nominating Committee Chair will participate (along with the Membership Chair and certain Officers) in the selection of AAWGT member scholarship recipients.

7. "Policies & Procedures Committee" becomes Governance Committee.

8. Bylaws will be reviewed by Steering Committee at least once a year and recommended changes will be drafted by the Governance Committee. The Steering Committee will approve and then send suggested changes to the members for discussion and approval at a general meeting.
